### 1. PRO VICE-CHANCELLOR

### **QUALIFICATION AND EXPERIENCE**

Applicants interested in the position of Pro Vice-Chancellor at Ghana Communication Technology University will be required to have the following:

xi. Contemporary ICT skills and knowledge of technology-driven administrative systems.
